On October 8, 2020. only one month before the 2020 general election, Muskegon, MI City Clerk Ann Meisch noticed a black female (whose name was redacted from the police report), dropping off between 8,000-10,000 completed voter registration applications at the city clerk's office.

The Muskegon Police Department was contacted and asked to investigate. On 10/21/20 First Lieutenant Mike Anderson was contacted by Tom Fabus, Chief of Investigations for Michigan Attorney General Dana Nessel's Office. According to the MI State Police report, Mr. Fabus asked for Michigan State Police assistance with a joint investigation of alleged voter fraud being conducted by the Muskegon Police Department and the AG.

An investigative task force was formed, and an investigation was initiated.

#### **The following is from the MI State Police report:**

*On 10/16/20 Muskegon City Clerk Ann Meisch and Deputy Clerk Kimberly Young **contacted the Muskegon Police Department** after noticing irregularities in voter registration applications received both in person and by mail.*

The Muskegon city clerk became suspicious when the female, (whose name is redacted in the first part of the police report, but then later, is *unredacted*), hand-delivered thousands of voter registrations to her office, many of them in the **same handwriting**.

*On 10/20/20 (deadline day for in-person voter registration applications) the suspect returned to the \*Muskegon City Clerk's office to deliver additional registration forms in person. Meisch estimated that (suspect) brought an additional 2500 forms. Meisch contacted the Muskegon Police Department and Detective Logan Anderson and Captain Shawn Bride conducted a non-custodial interview with the suspect.*

*Meisch stated that in her opinion a **quantity of the voter registration forms were highly suspicious and possibly fraudulent.***

*Meisch's opinion was based on the fact that **numerous forms appeared to have been completed by the same writer and upon initial examination, addresses on multiple forms were invalid or non-existent.***

*Meisch investigated further and found that **phone numbers on multiple forms were erroneous and signatures on multiple forms didn't appear to match signatures on file with the Department of Secretary of State.** Examples included an address in the and another in the [REDACTED]*

***Those addresses do not exist in the Muskegon City house numbering system.** Another form listed 80 W. Southern Ave which is the **address for Muskegon High School** and is clearly not a residence.*

Later in the report, the name of the female suspect was unredacted.

The MI State Police investigator assigned to the case spoke with the female suspect who explained that she was being paid \$1150/week "to find un-registered voters and provide them with a form so they can get registered to vote or obtain their absentee ballot." The only problem is, the handwriting on the voter registrations was the same on several of the registrations and many of the addresses were non-existent or fake.

MI Attorney General Dana Nessel, who is currently attempting to prosecute 15 senior citizens and the former MI GOP co-chair for casting an alternate set of electoral votes in the 2020 election, asked the MI State Police to join the Muskegon Police and AG's investigation of the potentially massive, multi-city voter fraud operation.

Two members of AG Dana Nessel's Criminal Investigation Division were assigned to the operation, yet curiously, she failed to mention the investigation to the public. To this day, Dana Nessel is still claiming there was no evidence of widespread voter fraud in Michigan, despite the fact that she knew her office and the office of her friend, Michigan's crooked SOS Jocelyn Benson, were involved with the MI State Police in a large scale investigation that took place across the state before it was taken over by the FBI.



Corey Ames, a MI SOS analyst CONFIRMED “a quantity of the forms they found in their investigation “are **clearly fraudulent.**” MI SOS Jocelyn Benson also claimed there was no widespread voter fraud in Michigan and neglected to mention the investigation to the public.

After consulting with Muskegon PD Detectives and MDOS Analyst Corey Ames your affiant would describe the results as finding that a quantity of the voter applications forms are clearly fraudulent, a quantity of the voter application forms are highly suspicious having either erroneous or are missing key pieces of information and merit further follow up and a quantity of the voter registration forms appear to be legitimate based on cross checks and database reviews.

**Today, The Gateway Pundit and our close friends from Michigan are exposing this damning report. The evidence from this investigation exposes criminal election fraud involving thousands of fraudulent ballots in Michigan by an organization that set up temporary offices in several swing states prior to the 2020 election.**

**This explosive investigation was covered up and buried from the public, until today.**

It should be noted that after documenting these crimes and investigating for weeks, the Michigan police turned their investigation over to the FBI who promptly buried the findings. Once again, the FBI apparently took no action—more on that in an upcoming report.

The police in Muskegon were investigating voter fraud in October 2020, a month prior to the general election. The FBI failed to follow-up on the alleged election crimes according to Michigan election investigator Phil O'Halloran. O'Halloran is now the Election Integrity Chair of the Michigan Republican Party.

The police report has redactions throughout, but not all names were redacted. The police report names 'GBI Strategies' as the organization running the scheme. The Tennessee-based group is heavily connected to the Biden campaign and various Democrat campaign committees. The released report also names "Brilus" as a primary person involved.

The police report from 2020 revealed that GBI Strategies has been in operation since 2014. And, the investigators found that GBI Strategies was paid \$1,571,386 by the Doug Jones for Senate campaign back in 2018. That was just one race they were involved in.

**The investigators also found that GBI Strategies was paid \$188,000 by the Democratic Senatorial Campaign Committee in 2018.** (paragraph 11)

11. On 10/26/20 MSP Intelligence Analyst Degroot researched [REDACTED] using the Center for Responsive Politics Website. Degroot found that [REDACTED] had a vendor recipient profile dating back to 2014. In the 2018 campaign cycle Degroot found that [REDACTED] was paid \$1,571,386 by the Doug Jones for Senate Committee, \$657,260 by the New American Jobs Fund and \$188,000 by the Democratic Senatorial Campaign Committee.

The employees at GBI Strategies were being paid \$15 an hour or \$120 a day. (paragraph 8)

8. On 10/26/20 your affiant did a Google Search for [REDACTED]. Your affiant found job postings offered by [REDACTED] on "Jobsearcher.com and JobAtic.com". The posting on Jobatic.com by [REDACTED] offered an administrative assistant position in Muskegon Heights, MI. The posting stated that the position paid \$15.00 per hour for data entry working on a voter registration project. The position description stated the person would check the accuracy of voter registration cards while entering them into a system and would be calling registrants to get information for incomplete cards, scan the cards and help with payroll.

A woman interviewed by police said she was paid \$1150 per week and given a rental car. She said she was given a "reloadable pay card." (paragraph 3)

Police reported that hundreds of pre-paid cards from "different" companies, along with "dozens of new (burner?) phones were found in the Southfield raid in Michigan.



The rear store room and office had items associated with manager Brilus (backpack, computer and phone). Several wire storage racks surrounded the border of the room with a white board and bulletin board on other walls. Dozens of new phones were located in boxes. Hundreds of pre-paid payment cards were also found unopened and addressed to [REDACTED]. The cards were from two different companies.

The police report noted that there were numerous job openings listed in Flint, Michigan and Regional Field Manager postings in Washington DC and Chicago, Illinois. This group had branches across the nation.

During their investigation, the police also found partially completed voter registration forms and police found **“pelican cases in the room with semi-automatic rifles joined with suppressors and optics and customized pistols.”** One case had **“4 rifles and 4 pistols.”**

Binders containing employee information, completed van manifests and completed and partially completed voter registration forms were found in the room. In addition to the shelving the room had a long table in the middle with several chairs. Some of the partially completed voter registration applications with sticky notes were found on this table.

Detectives also found pelican cases in the room with semi-automatic rifles joined with suppressors and optics and customized pistols. Brilus indicated that the weapons belonged to owner [REDACTED]. Detectives later found a binder in the room containing valid tax stamps for the suppressors, receipts for several accessories, trust paperwork for the future transfer of the weapons and other documentation. An ATF agent was called to the scene. The weapons were field tested for being fully automatic, examined and found to be legal. One case had 4 rifles and 4 pistols. The other case had 1 rifle and second weapon that appeared to be a short-barreled rifle but qualified as a pistol with a folding stock. The weapons were secured and left in the custody of [REDACTED].

One of the white boards had several notes on it. One of the categories was “Hot Topics”. Under “Hot Topics” listed: weapons in the field, prepared for shifts, Covid questionnaire needs to be asked whether canvasser is new or not, mask enforcement, no eating in vans. Another heading was “Tiff GA Project” and the words underneath: 44 Paycards, 30 Phones, 20 tablets. Another heading was “Charleston to Columbia” with the

The police report claims these weapons were determined to be legal and lawful after calling in the ATF to inspect the weapons.

The affiant (witness who filled out the affidavit) first witnessed minivans moving from a hotel in Grand Haven to the location of the business, a former California Eyecare location. The next day Detective Luker was notified. He went to the address where he found a bag of trash filled with information on employee agreements.

check out at 10/29/20. Detective Eric Rasch from Grand Haven DPS contacted management and confirmed that [redacted] and is due to check out by 11am on 10/29/20.

20. On 10/28/20 your affiant watched the business located at [redacted]. At approximately 5pm three different Dodge Rental mini-vans including the one that was followed from [redacted] hotel in Grand Haven were observed at the business front. All were found to be rental vehicles [redacted]. Numerous unknown persons were witnessed getting out of the mini-van vans and both coming in and going out of the front door of the business. Your affiant ran a Google search and found the California Eyecare is a permanently closed business.

21. On 10/29/20 at approximately 10:30am your affiant spoke with Detective Luker. Detective Luker stated they went to [redacted] at approximately 10:00am and observed three parked mini-vans at the business but no persons inside the business or the vans. Detective Luker was able to retrieve a bag of trash found near the dumpster at the rear of the business. Detective Luker found paper in the bag with [redacted] information about employee agreements, potential [redacted] [redacted]

20. Your affiant believes that [redacted] is the temporary business office for Muskegon Operations based on surveillance and the documents found in the trash. Your affiant believes documents, financial

The affiant believed the records found at the location were crucial to determining the crime of Election Fraud Forgery and determining who may be criminally liable and who may have profited from the fraud.

records and electronic files located in the business are crucial to determining the crime of Election Fraud Forgery and determining who may be criminally liable and who may have profited from the fraud. Your affiant is aware from prior investigations that phone calls, emails, direct messages and text message history in addition to financial records are all essential to prove or disprove Election Fraud Forgery by following the trail of money and determining the "System" that claims to be in use by [redacted] to determine each applications accuracy and authenticity.

The affiant later obtained a copy of the Mukegon PD Report 2020-19124 authored by Officer Foster with a supplemental report by Detective Logan Anderson along with a copy of the search warrant of the business location.

This next paragraph from the police document reveals that Muskegon City Clerk Ann Meisch and Deputy Clerk Kimberly Young first contacted the police on October 16, 2020.

Meisch and Young contacted police after receiving multiple "State of Michigan Voter Registration Application" forms which in their opinion appeared to be fraudulent. According to the report, Meisch based her opinion on the fact that some of the addresses on the applications appeared to be invalid or non-existent. Also, some of the phone numbers were invalid and some signatures did match those on file.

Meisch also noted that the handwriting on the ballots appeared to be the same with a similar signature and ALL OF THE BALLOTS appeared to come from the same company with two locations in Southfield and Auburn Hills.

Meisch told police some of the forms were dropped off in person to the Muskegon City Clerk's office by a black female who identified herself as Brianna Hawkins. Miss Hawkins said her employment entailed registering voters and helping them obtain absentee ballots.

Meisch estimated that the leftist organization delivered approximately 8,000-10,000 voter registration forms to the Muskegon City Clerk's office and provided a sampling of 42 suspected fraudulent applications to Officer Foster for examination. Meisch stated they identified by viewing her Facebook profile.

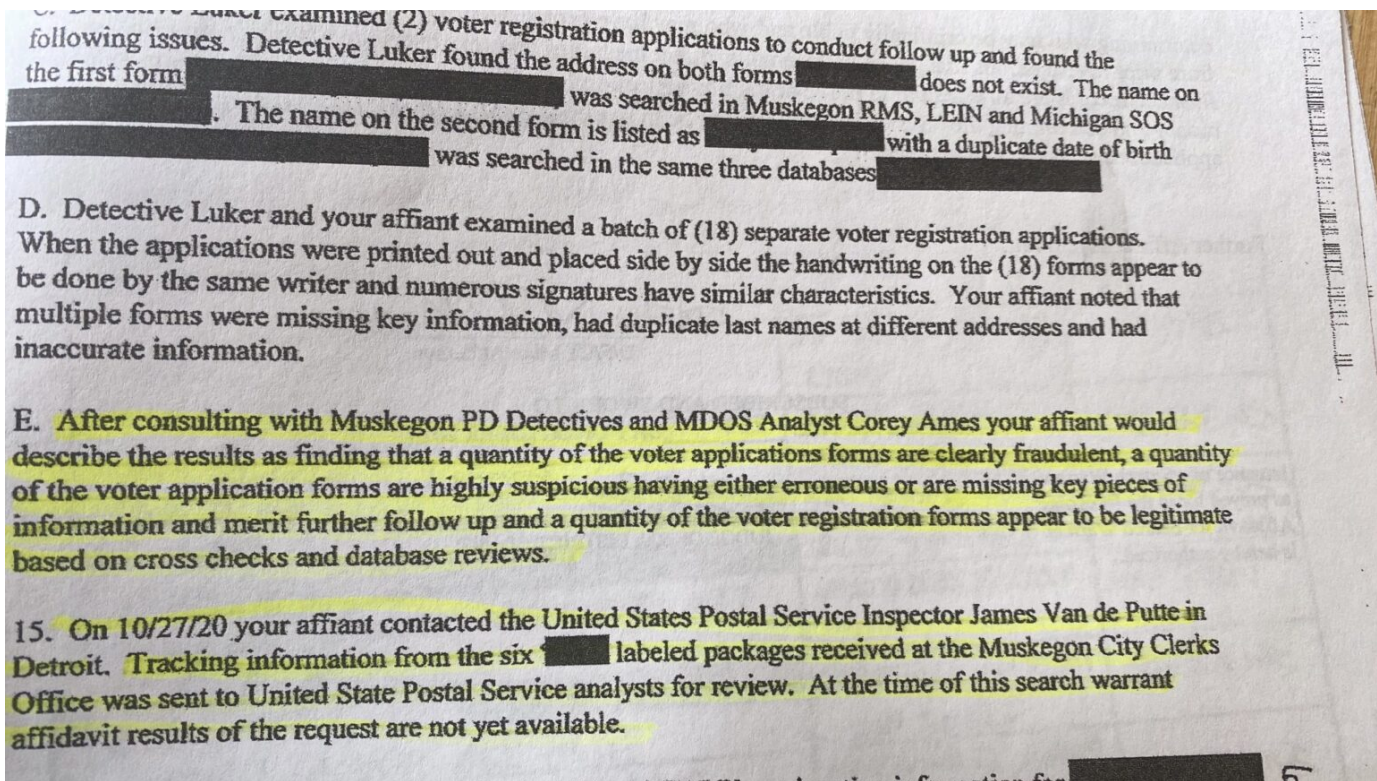
Employee Brianna Hawkins dropped off between 8K -10K registrations in ONE day!

2. Your affiant obtained a copy of Muskegon PD Report 2020-19124 authored by Officer Foster with a supplemental report from Detective Logan Anderson. In addition your affiant obtained a copy of a search warrant authored by Detective Kory Luker for GPS location information for suspect [REDACTED]

3. In reviewing Muskegon PD Report 2020-19124 your affiant learned the following: On 10/16/20 Muskegon City Clerk Ann Meisch and Deputy Clerk Kimberly Young contacted the Muskegon Police Department after receiving multiple "State of Michigan Voter Registration Application" forms which in their opinion appeared to be fraudulent. Meisch based this opinion on the fact that some of the addresses on the applications appeared to be invalid or non-existent, some of the phone numbers were invalid and some of the signatures on the forms did not match the signatures on file with Secretary of State. For example one form listed an address in the [REDACTED] Those addresses do not exist in the Muskegon City house numbering system. Another form listed [REDACTED] Ave which is the address for the Muskegon High School and clearly isn't a residence. Meisch also noted that the handwriting on multiple applications appeared to be the same with a similar signature and that all the applications came from the same company [REDACTED] with two locations in Southfield [REDACTED] and Auburn Hills [REDACTED], MI. The two addresses were found on return mailing labels from United State Postal Service Packaging used to mail the Voter Registration Forms. Meisch stated some of the forms were dropped off in person to the Muskegon City Clerk's Office on 10/8/20 by a black female. The female identified herself as Brianna Hawkins and stated she was employed by [REDACTED] and/or [REDACTED] told Meisch that her employment entailed registering voters and helping them obtain absentee ballots. [REDACTED] provided Meisch with a mobile phone number of [REDACTED] Meisch said that [REDACTED] appeared nervous to talk about her employment and said she would need to call her supervisor before answering any additional questions. Meisch estimated that [REDACTED] and [REDACTED] had delivered approximately 8,000-10,000 voter registration forms to the Muskegon City Clerk's office and provided a sampling of 42 suspected fraudulent applications to Officer Foster for examination. Meisch stated they identified [REDACTED] by viewing her Facebook profile.

4. On 10/20/20 [REDACTED] returned to the Muskegon City Clerk's office with the intent to deliver registration [REDACTED] Detective Logan Anderson and Captain Shawn Bride.

The investigators found that "a number of voter applications forms were clearly fraudulent."



The report notes that police found, **“Dozens of new phones”** and **“Hundreds of pre-paid payment cards”** – these items were clearly considered suspicious by the police in the report.

Also in the report: the left-wing ballot organizing group had suppressors (Silencers) and automatic weapons for some odd reason.

Nearly three years later, President Trump faces multiple prosecutions because he ‘fraudulently’ pursued ‘baseless’ claims of voter fraud according to prosecutors and the mainstream media. On election night, a suspicious 3:30 AM van delivering the Biden Ballot Dump in Detroit at the facility formerly known as the TCF Center was accompanied by a vehicle registered to a rental car company.

The Gateway Pundit previously obtained the video and broke the story.



The Gateway Pundit has always reported that there were unanswered statistical anomalies within the absentee data. Repeated trends across the state of Michigan that appear to show systemic voter fraud among absentee ballots.

Michigan State Senator Ruth Johnson, who is a former Secretary of State, told the Gateway Pundit: **“My estimate is over 800,000 ballot applications were sent to non-qualified voters in Michigan**, including many individuals who moved or died, and even some individuals who were underage or non-citizens. Many were sent to people who had moved out of state.” These ballot applications, if turned back in, would cause a live ballot to then be sent to that address by the clerk. Both the ballot applications and the live ballots were not seriously checked for a ‘signature match’ because Democrat Secretary of State Jocelyn Benson purposefully advised clerks to illegally assume and presume the signatures were a match.

This tip from Muskegon clerk Ann Meisch, who has been the City Clerk of Muskegon since 2007, was referred to the FBI. Clerk Meisch has been a City Clerk for other Michigan cities for 17 years before that. There's no evidence the FBI did anything with this investigation. And in fact, the Bill Barr [appointed DOJ attorney overseeing election fraud cases](#) was notorious for political persecution against conservatives.

In a recent post on his social media platform, Truth Social, former President Donald Trump praised the analysis and comments made by [Dr. Jan Halper-Hayes](#) during a recent interview.

Halper-Hayes, a former Global Vice President of Republicans Overseas UK, made headlines with her statements during an appearance with a British morning news show, [Breakfast with Stephen and Ellie](#), last Thursday.

Halper-Hayes pushed back against the widely held belief that Trump's case is based solely on political conspiracy theories, arguing that there are significant questions about election integrity that require attention. She further contended that the current indictment has inadvertently given Trump a platform to present his case and expose possible election irregularities.

During the interview, Halper-Hayes claimed to be part of a Department of Defense (DoD) Task Force, asserting that Space Force had evidence proving the fraudulent nature of the 2020 election. Of course, The Gateway Pundit can neither confirm nor deny these allegations at this time.

According to Halper-Hayes, Trump had chosen not to disclose such evidence early to prevent civil unrest, believing it could lead to a civil war.

"I sit on a task force at the Department of Defense, and the thing is, they've got the goods. They've got the goods. And Trump knew that if he presented any of the goods early on, we'd have a civil war, that

he really felt that the people needed to see how bad it could get," said Halper-Hayes.

"See, the thing is, think about Edward Snowden and all the information he had. Think about the fact that our military, our Department of Defense Space Force, if you think that they don't have the actual real results from the election, then you're fooling yourself," said Halper-Hayes.

The **United States Space Force (USSF)** is a branch of the U.S. military that was established by the Trump administration. Its creation was officially enacted by the signing of the National Defense Authorization Act for 2020 on December 20, 2019.

Its mission is to organize, train, and equip space forces in order to protect U.S. and allied interests in space and to provide space

capabilities to the joint force.

Dr. Halper-Hayes further delved into [Executive Order 13848](#)," enacted by Trump on September 12, 2018, arguing that it was designed to combat foreign interference in U.S. elections, with a focus on the 2020 elections.

"Now, let me say something about this 2020 election, is that Biden is the legitimate president, but he's the legitimate president of what is now the bankrupt US. Corporation and that was a treaty in 1871," said Halper-Hayes.

The [Treaty of 1871](#), also known as the Treaty of Washington, was an agreement between the United States and the United Kingdom. The two nations were aiming to settle disputes that had lingered since the American Civil War.

She continued, "Well, on September 12, 2018, Trump created an executive order. Within that, he outlined in future elections any kind of foreign or domestic interference specifically for the 2020 election. So we say, how did he know some of these things were going to happen? Election integrity on both sides of the aisle is tough. It's really tough. But what this has done is it opened the door for Trump to present his case."

Halper-Hayes also suggested that Trump had signaled his intent to dissolve the U.S. corporation and return the country to its original state as a Republic during a meeting with the Queen of England. She claimed that this move led to a substantial transfer of gold from the Vatican Bank.

Dr. Jan Halper-Hayes said:

"They made fun of him because they assumed he broke protocol and walked in front of the Queen. No, if you go back and look at it,

you will see he looked at her. She gave a wave with her hand. He proceeded, she took a couple of steps, he stopped, and he waited for her to join.

“That was an optic to tell us that he then was going to bankrupt the US corporation because it was the Vatican, the Crown, and the US that was part of since 1871. And we were giving you our tax dollars. We were paying back, forget this Tea Party, and without taxation, without representation, we owed you a lot of money because you helped us in the civil war.

The liberal media has claimed that Cannon revealed that an “out-of-district grand jury” is investigating the classified documents case. But Kelly notes it was Jack Smith who did this in a motion filed just last week.



Cannon observed in her verdict that “the Special Counsel states in conclusory terms that the supplement should be sealed from public view “to comport with grand jury secrecy,” but the motion for leave and the supplement plainly fail to satisfy the burden of establishing a sufficient legal or factual basis to warrant sealing the motion and supplement.”

**She then denied the motion by the prosecution.**

Cannon next wrote in her verdict against Smith that “Among other topics as raised in the Motion, the response shall address the legal propriety of using

an out-of-district grand jury proceeding to continue to investigate and/or to seek post-indictment hearings on matters pertinent to the instant indicted matter in this district."

The prosecution has been ordered by Cannon to respond to these and other items by no later than August 22nd.

Nauta's lawyers will need to respond to the motion for the hearing and address the existence of the grand jury by Aug. 17.

Former first lady Melania Trump has reportedly become a source for comfort for her husband as he faces mounting state and federal indictments and as he is running for a second term as president.

“Friends whisper these last few weeks have been hard on Trump, and although he always presents a tough front, these constant legal assaults are affecting his day-to-day life,” the source said.

Melania has reportedly taken on a role behind the scenes to offer a sense of calm.

“Melania’s even better than his regular golf games at keeping his temper in check,” the person said. “She provides a peaceful life for him when he needs it.”

The source added Trump eats breakfast daily with Melania and their son **Barron** and that the former first lady “turns the news off at times so they can watch something else together, and she frowns over telephone or social media use at the table.”

She also is said to be 100 percent in support of Trump’s third **presidential bid**.

“She backs his bid for a second term completely, and listens to him when he needs someone he can trust,” the source reportedly said. “[Melania] is obsessively private, she never gossips with even her closest friends, so Trump knows when they talk about important things it’s just between them.”

Trump was first **indicted** in April in New York City and charged with 34 felony counts of falsifying business records by Manhattan District Attorney Alvin Bragg.

Two months later, in June, a federal grand jury voted to indict him in regard to the alleged mishandling of **classified documents** that were being stored at his Mar-a-Lago home and resort.

Special counsel [Jack Smith](#) charged the former president with dozens of counts, including willful retention of national defense information, conspiracy to obstruct justice and making false statements and representations.

Last week, Smith struck again by [charging](#) Trump for his decision to challenge the results of the 2020 election.

The Department of Justice has charged Trump with conspiracy to defraud the U.S., obstruction of an official proceeding, conspiracy to obstruct an official proceeding and conspiracy to prevent others from carrying out their constitutional rights.

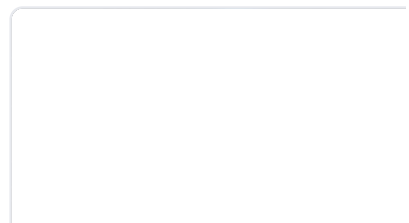
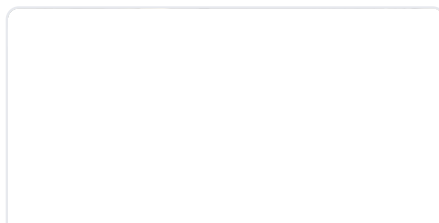
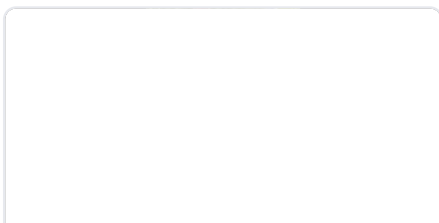

As many pundits following the Hunter Biden investigation suspected, Archer also confirmed that now-President Biden was lying when he said he never met with or discussed his son's foreign business associates, "telling the committee America's current president got on speakerphone more than 20 times with his son's business clients."

JTN, relying on the source, reports that "Archer testified that Joe Biden did not engage in business specific on such calls, instead he "was put on the phone to sell 'the brand.'"



Hunter Biden's longtime friend and former business partner Devon Archer testified to congressional lawmakers Monday that "Burisma Holdings pressured Hunter in December 2015 to deal with a Ukrainian prosecutor who was investigating the firm for corruption shortly before the then-vice president took steps to force the prosecutor's firing," a source "directly familiar" with Archer's transcribed interview told [Just the News](#).


Archer told the House Oversight and Accountability Committee that "Hunter Biden was added to Burisma's board in 2014 because his family's 'brand' brought value at a time when the firm was facing corruption allegations from the United States, Great Britain and Ukraine's own prosecutor general office," according to the anonymous source, who spoke with JTN while Archer's interview was still ongoing Monday afternoon.

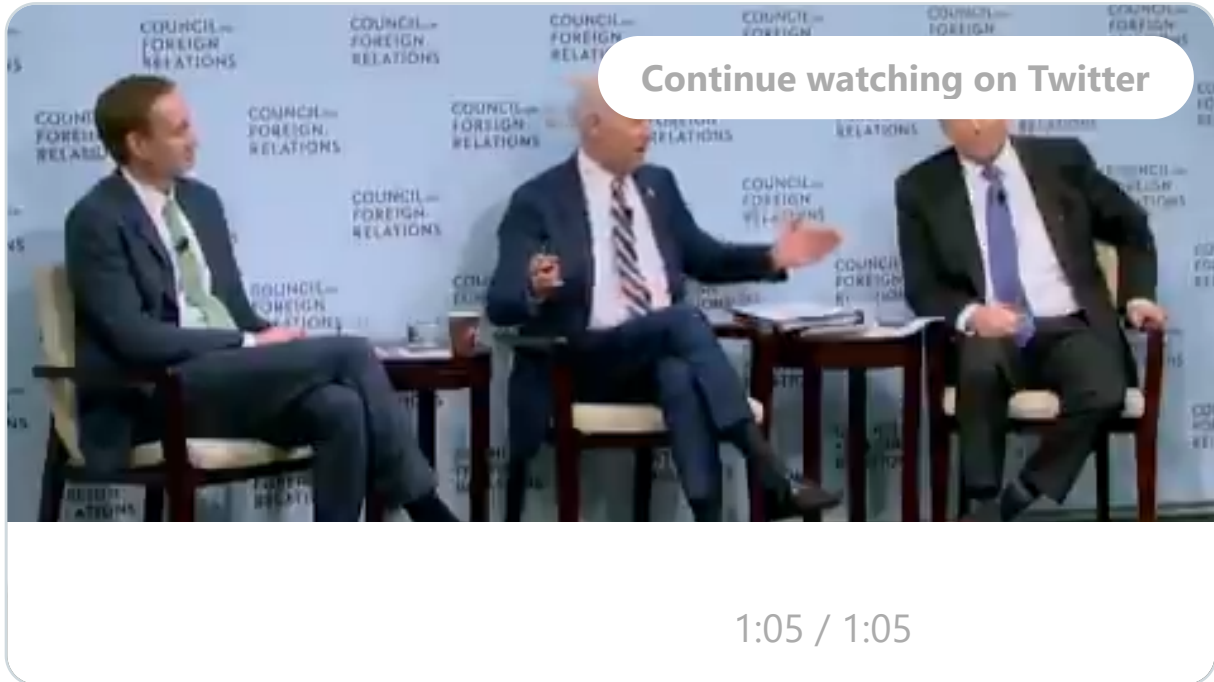

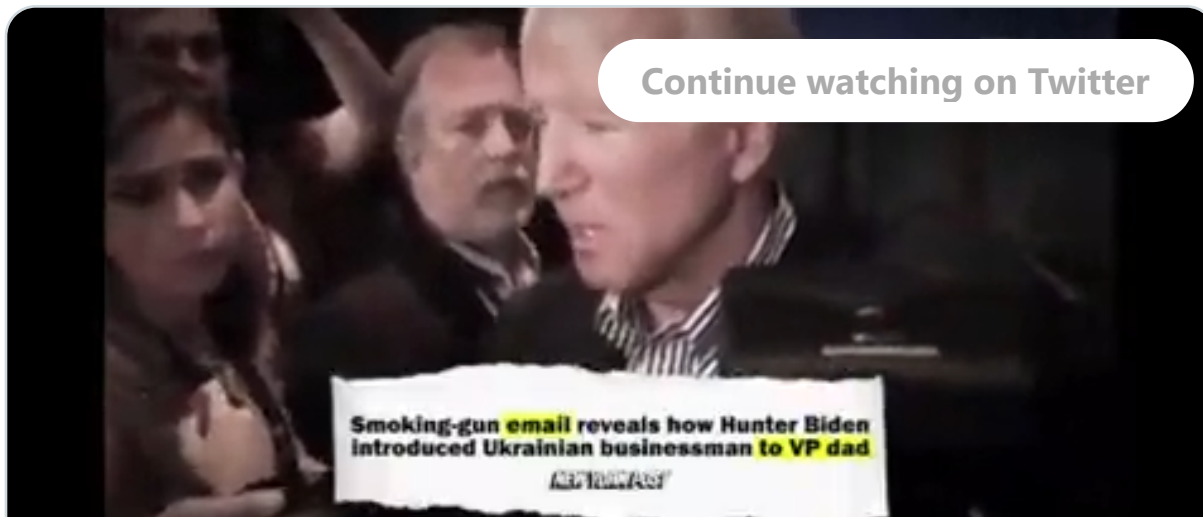
