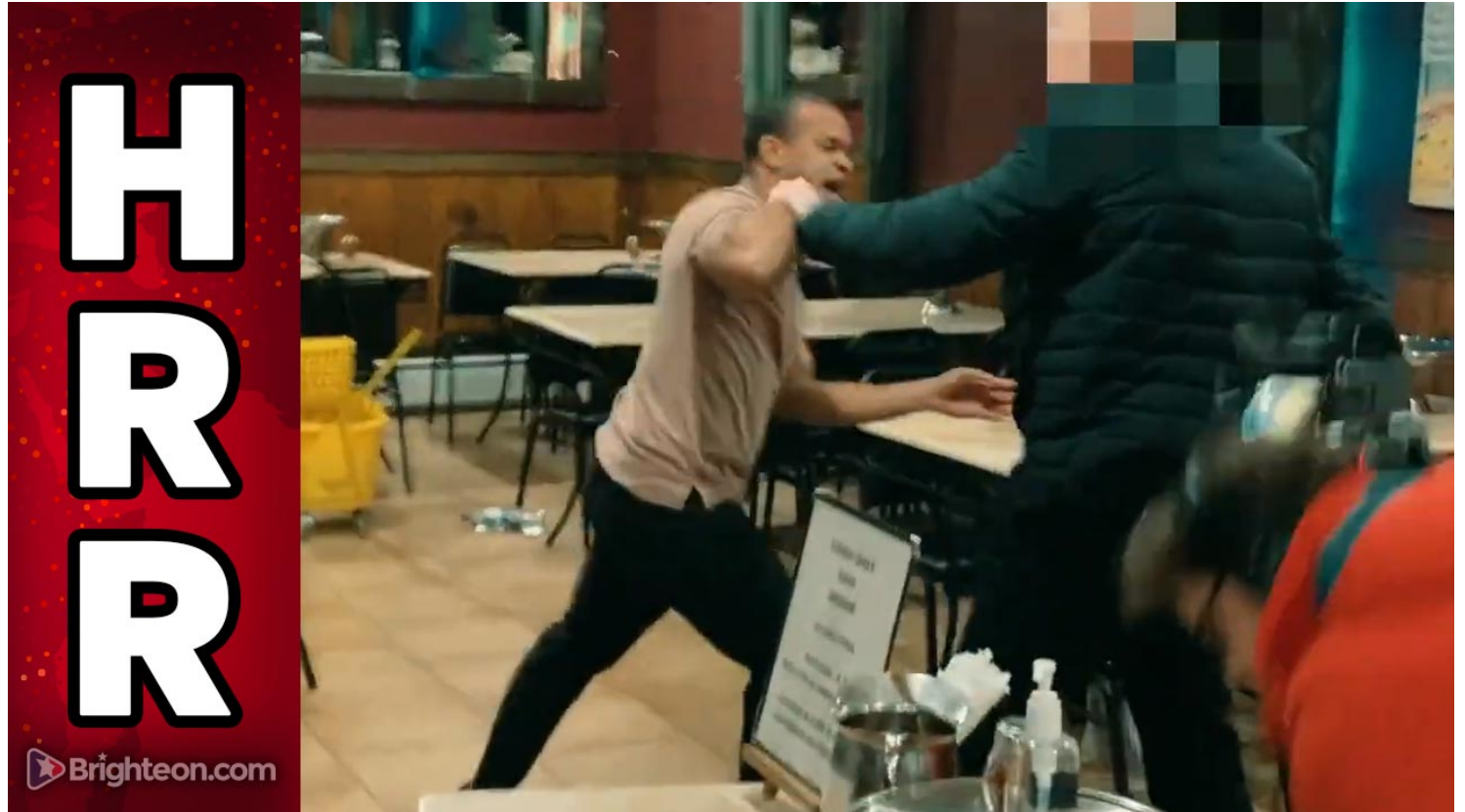


# Phreakazoid Pfizer executive goes BERSERK when confronted by Project Veritas over HIS OWN claims of virus mutation research and vaccine profiteering

# Project Veritas BOMBSHELL: Pfizer director admits company carries out illegal gain-of-function research

(Natural News) Dr. Robert Malone had the privilege of helping Project Veritas put together a new exposé about Pfizer’s covid cash cow: its mRNA covid “vaccine.”

An undercover Project Veritas reporter spoke with Jordon Trishton Walker, who is in charge of Pfizer’s research and development, strategic operations, and mRNA scientific planning division. What he revealed is nothing short of shocking.

In essence, Pfizer is engaged in illegal gain-of-function research – or some tweaked version of it called “directed evolution” – that the company is using to develop an endless stream of new injections for all the latest “variants” and “subvariants.”

Walker admitted on tape that Pfizer is working on intentionally “mutating” the disease so it evades all previous mRNA injections – that way those who took the initial series and boosters

will need to take even more of them in the coming months and years.

## **Is Pfizer creating and unleashing new covid strains so people keep taking its latest vaccines?**

In a nutshell, Walker confirmed what many have already long known about Pfizer: that the company only cares about money. Pfizer also has no ethics or morals, so it is willing to do whatever it takes to get that money – including by committing crimes.

Walker admitted, then tried to backtrack, that Pfizer is essentially performing gain-of-function research – but with a twist – on the covid virus. Its goal is to get ahead of the latest variants and subvariants by already having new injections ready before they appear.

Much like how vaccine corporations try to predict what the next “seasonal flu” strain will be in advance, Pfizer has begun tampering with covid in an effort to see how it might mutate next in order to have new vaccines ready and waiting.

“You’re not supposed to do gain of function research with the viruses,” Walker said. “They recommend not. But you do things like selected directional mutations to try to see if you can make it more potent.”

In other words, Pfizer is manipulating covid in an attempt to make it stronger and more infectious – and maybe even more deadly. Then the company plans to have the “cure” ready for people after the more potent strain has been released.

“They’re still kind of conducting the experiments on it, but it seems like from what I’ve heard they’re kind of optimizing it,” Walker added about Pfizer’s work on mutating covid. “But they’re going slow because everyone’s very cautious. They obviously don’t want to accelerate too much.”



Walker then admitted to the reporter that this was Pfizer's plan all along: to keep covid as "a cash cow" that continues to generate obscene profits for the company. And with the help of "revolving door" politics between government and industry, there should be no problems getting each new vaccine iteration approved and released at *warp speed*.

"The gentleman seems to have absolutely no moral compass at all about what he's doing. The hubris and arrogance and immaturity," Malone commented about Walker's admissions during the interview.

"If this is the quality of individuals within Pfizer that are making these huge decisions that risk global public health with such a casual disregard for the human toll, it's profoundly corrupt in terms of would it be feasible for Pfizer to circumvent international or national law? I think that is undeniable."

[NEW YORK – Jan. 25, 2023] Project Veritas released a new video today exposing a Pfizer executive, Jordon Trishton Walker, who claims that his company is exploring a way to "mutate" COVID via "Directed Evolution" to preempt the development of future vaccines.



Walker says that Directed Evolution is different than Gain-of-Function, which is defined as "a mutation that confers new or enhanced activity on a protein." In other words, it means that a virus such as COVID can become more potent depending on the mutation / scientific experiment performed on it.

The Pfizer executive told a Veritas journalist about his company's plan for COVID vaccines, while acknowledging that people would not like this information if it went public.

"One of the things we [Pfizer] are exploring is like, why don't we just mutate it [COVID] ourselves so we could create -- preemptively develop new vaccines, right? So, we have to do that. If we're gonna do that though, there's a risk of like, as you could imagine -- no one wants to be having a pharma company mutating f\*\*king viruses," Walker said.

"From what I've heard is they [Pfizer scientists] are optimizing it [COVID mutation process], but they're going slow because everyone is very cautious -- obviously they don't want to accelerate it too

much. I think they are also just trying to do it as an exploratory thing because you obviously don't want to advertise that you are figuring out future mutations," he said.

Walker drew parallels between this current Pfizer project and what may have happened at the Wuhan Institute of Virology in China.

"You have to be very controlled to make sure that this virus [COVID] that you mutate doesn't create something that just goes everywhere. Which, I suspect, is the way that the virus started in Wuhan, to be honest. It makes no sense that this virus popped out of nowhere. It's bullsh\*t," he said.

"You're not supposed to do Gain-of-Function research with viruses. Regularly not. We can do these selected structure mutations to make them more potent. There is research ongoing about that. I don't know how that is going to work. There better not be any more outbreaks because Jesus Christ," he said.

Walker also told the Veritas journalist that COVID has been instrumental for Pfizer's recent business success:

**Walker:***Part of what they [Pfizer scientists] want to do is, to some extent, to try to figure out, you know, how there are all these new strains and variants that just pop up. So, it's like trying to catch them before they pop up and we can develop a vaccine prophylactically, like, for new variants. So, that's why they like, do it controlled in a lab, where they say this is a new epitope, and so if it comes out later on in the public, we already have a vaccine working.*

**Veritas Journalist:***Oh my God. That's perfect. Isn't that the best business model though? Just control nature before nature even happens itself? Right?*

**Walker:***Yeah. If it works.*

**Veritas Journalist:***What do you mean if it works?*

**Walker:***Because some of the times there are mutations that pop up that we are not prepared for. Like with Delta and Omicron. And things like that. Who knows? Either way, it's going to be a cash cow. COVID is going to be a cash cow for us for a while going forward. Like obviously.*

**Veritas Journalist:***Well, I think the whole research of the viruses and mutating it, like, would be the ultimate cash cow.*

**Walker:** *Yeah, it'd be perfect.*

Walker went on to explain how Big Pharma and government officials, such as at the Food & Drug Administration [FDA], have mutual interests, and how that is not in the best interest of the American people:

**Walker:** *[Big Pharma] is a revolving door for all government officials.*

**Veritas Journalist:** *Wow.*

**Walker:** *In any industry though. So, in the pharma industry, all the people who review our drugs -- eventually most of them will come work for pharma companies. And in the military, defense government officials eventually work for defense companies afterwards.*

...

**Veritas Journalist:** *How do you feel about that revolving door?*

**Walker:** *It's pretty good for the industry to be honest. It's bad for everybody else in America.*

**Veritas Journalist:** *Why is it bad for everybody else?*

**Walker:** *Because when the regulators reviewing our drugs know that once they stop regulating, they are going to work for the company, they are not going to be as hard towards the company that's going to give them a job.*

## BREAKING: Pfizer RESPONDS to Project Veritas' 'Bombshell' Undercover Video Showing Exec's Remarks on 'Mutating' Viruses

Pfizer is responding to an undercover video from Project Veritas that appears to show an R&D executive named Jordon Trishton Walker bragging about the company discussing intentionally mutating viruses in order to sell future vaccines.

The undercover video racked up over 20 million views on Twitter shortly after Project Veritas' reinstatement on the social media platform.

This is what Pfizer had to say about the video in a statement on its official company [website](#) (passages of particular significance have been bolded by the editor):

*Allegations have recently been made related to gain of function and directed evolution research at Pfizer and the company would like to set the record straight.*

*In the **ongoing** development of the Pfizer-BioNTech COVID-19 vaccine, **Pfizer has not conducted gain of function or directed evolution research.** Working with collaborators, we have conducted research where the **original SARS-CoV-2 virus has been used to express the spike protein from new variants of concern.** This work is undertaken once a new variant of concern has been identified by public health authorities. This research provides a way for us to rapidly assess the ability of an existing vaccine to induce antibodies that neutralize a newly identified variant of concern. We then make this data available through peer reviewed scientific*

*journals and use it as one of the steps to determine whether a vaccine update is required.*

Pfizer then pivots to touting its Covid treatment drug Paxlovid.

*In addition, to meet U.S. and global regulatory requirements for our oral treatment, PAXLOVID™, Pfizer undertakes in vitro work (e.g., in a laboratory culture dish) to identify potential resistance mutations to nirmatrelvir, one of PAXLOVID's two components. With a naturally evolving virus, it is important to routinely assess the activity of an antiviral. **Most of this work** is conducted using computer simulations or **mutations of the main protease—a non-infectious part of the virus.***

*In a limited number of cases when a full virus does not contain any known gain of function mutations, **such virus may be engineered to enable the assessment of antiviral activity in cells.** In addition, in vitro resistance selection experiments are undertaken in cells incubated with SARS-CoV-2 and nirmatrelvir in our secure Biosafety level 3 (BSL3) laboratory to assess whether the main protease can mutate to yield resistant strains of the virus. It is important to note that these studies are required by U.S. and global regulators for all antiviral products and are carried out by many companies and academic institutions in the U.S. and around the world.*

*Fact-based information rooted in sound science is vitally important to overcoming the COVID-19 pandemic and Pfizer remains committed to transparency and helping alleviate the devastating burden of this disease.*

It should be noted that this carefully worded statement does not deny that Jordon Triston Walker works for Pfizer. Nor does it deny that he is the [director](#) of scientific and operational initiatives, which is directly salient to the statements made in the video. It does not directly address the content of the video.

It does not deny the possibility that Pfizer employees may have discussed the intentional

mutation of viruses to sell future vaccines. It does not rule out Pfizer subcontractors experimenting to explore such a possibility.

The Pfizer Director of Research and Development, Strategic Operations and mRNA Scientific Planner says in the video: “One of the things we’re exploring is like, why don’t we just mutate it [COVID] ourselves so we could create — preemptively develop new vaccines, right? So, we have to do that. If we’re gonna do that though, there’s a risk of like, as you could imagine — no one wants to be having a pharma company mutating f\*\*king viruses.”

Neither does Pfizer’s statement respond directly to Project Veritas. Nor does it threaten a lawsuit, which may lead to discovery.

The Project Veritas video prompted an ugly confrontation from Jordon Triston Walker and the video staff, as well as James O’Keefe himself, after he was confronted.

Walker claims in the video that he was merely trying to impress a date in the video, but did not elaborate on how boasting about weaponizing viruses to sell vaccines would leave a favorable impression.

Pfizer has been receiving heat from U.S. senators to answer for the profound implications of the



R&D director's claims.

On Thursday, Sen. Ron Johnson (R-WI) called for Congress to investigate both federal health agencies and Big Pharma.

Johnson on Thursday was joined by Senate colleague Marco Rubio (R-FL) with a request for answers about the video.

“I write in response to troubling reports on Pfizer’s intention to mutate the SARS-CoV-2 (COVID) virus through gain-of-function, or ‘directed evolution,’ as detailed by Pfizer Director of Research and Development, Jordan Walker,” Rubio’s office wrote. “As has been proven time and time again, attempts to mutate a virus, particularly one as potent as COVID, are dangerous. If the claims detailed in the video are true, Pfizer has put its desire for profit over the concern of national and global health and must hold itself accountable.”

Rubio then asked a series of questions, including:

- 1. What efforts is Pfizer currently, or planning to, engage in to mutate the SARS-CoV-2 virus?*
- 2. Does Pfizer intend to continue mutating the SARS-CoV-2 virus through gain-of-function, or directed evolution research, with the purpose of creating new vaccines before the variant is present in the greater population?*
- 3. Has Pfizer engaged with federal officials engaged regarding their plans to oversee this research? Please provide the names and agencies for these individuals.*
- 4. What steps has Pfizer taken to ensure the mutated virus does not leak from the laboratory and infect the greater population?*
- 5. Has Pfizer engaged with other biopharmaceutical companies to collaborate on this research effort? Please list the entities that you have been in contact with.*
- 6. Will you commit to halting any future research that mutates the SARS-CoV-2 vaccine as substantial evidence has indicated that similar dangerous research at the Wuhan Institute of Virology very likely led to the initial emergence and global spread of the virus?*

Let me put the Pfizergate scandal in perspective: The video shows a high-level exec discussing the company's plans to make bioweapons in order to sell the public the antidotes. This would be no less than a crime against humanity.

We desperately need a Nuremberg 2.0 to investigate Big Pharma's role in gain-of-function & directed evolution research. The Covid pandemic led to human rights violations. The NIH, CDC, WHO, CCP & every major public health agency needs to be held to account to the fullest degree.

Every related paper, email, and planning document needs to be compiled before an international tribunal. Public health officials need to be put on the stand and made to defend their actions before a panel of highly reputable judges. The fate of the free world depends on justice.

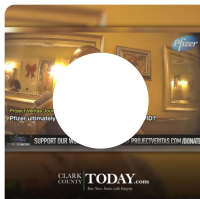

A research director with the pharmaceutical giant Pfizer said the corporation is secretly exploring intentionally creating mutations of the COVID virus to “preemptively develop new vaccines,” and said COVID “is going to be a cash cow for us,” in the latest [undercover video by Project Veritas](https://www.projectveritas.com/news/pfizer-executive-mutate-covid-via-directed-evolution-for-company-to-continue/) (<https://www.projectveritas.com/news/pfizer-executive-mutate-covid-via-directed-evolution-for-company-to-continue/>).

In the video released yesterday, Jordon Trishton Walker, Pfizer Director of Research and Development, Strategic Operations and mRNA Scientific Planner, says, “One of the things we’re exploring is like, why don’t we just mutate it [COVID] ourselves so we could create – preemptively develop new vaccines, right? So, we have to do that. If we’re gonna’ do that though, there’s a risk of like, as you could imagine – no one wants to be having a pharma company mutating f\*\*king viruses.”

“From what I’ve heard is they [Pfizer scientists] are optimizing it [COVID mutation process], but they’re going slow because everyone is very cautious – obviously they don’t want to accelerate it too much. I think they are also just trying to do it as an exploratory thing because you obviously don’t want to advertise that you are figuring out future mutations,” he says.

“Don’t tell anyone this. ... There is a risk ... have to be very controlled to make sure this virus you mutate doesn’t create something ... the way that the virus started in Wuhan, to be honest.”

He says it “makes no sense” and dismisses as “bull—t” the idea that COVID virus “popped out of nowhere.”

In the PV video, mRNA co-inventor and famed vaccine dissident Dr. Robert Malone (<https://twitter.com/RWMaloneMD>) comments regarding Walker: “The gentleman seems to have absolutely no moral compass at all.” Malone is now a leading crusader against COVID vaccines and governments’ COVID policies worldwide.

Pfizer faces escalating public scrutiny and skepticism as the establishment COVID narrative that the vaccines are “safe and effective” crumbles amidst growing evidence of dangerous side effects from the experimental shots. A 2022 JAMA study found that one in every 500 children under five years who received the Pfizer mRNA COVID vaccine were hospitalized with a vaccine injury, and one in 200 had “symptoms ongoing for weeks or months afterwards,” as WND reported (<https://www.wnd.com/2022/10/1-every-500-small-children-receive-pfizer-vaccine-hospitalized/>).

Pfizer’s CEO Albert Bourla recently refused to answer politically incorrect questions from an “ambush interview” (<https://www.wnd.com/2023/01/pfizer-ceo-epic-reaction-ambushed-conservative-journalists-davos/>) by conservative Rebel News, while attending the Davos World Economic Forum annual meeting in Davos, Switzerland.

When the undercover PV reporter says the “the whole ... research of the viruses and mutating [them] would be the ultimate cash cow,” Walker responds, “Yeah, it’d be perfect.”

Project Veritas founder James O’Keefe says on the video: “Now you would think that creating viruses to sell the vaccine would be illegal, but no, the pharmaceutical industry, as Walker puts it, is ‘a revolving door for all government officials.’”

“You’re not supposed to do gain-of-function research with viruses. Regularly not. We can do these selected structure mutations to make them more potent. There is research ongoing about that. I don’t know how that is going to work. There better not be any more outbreaks because Jesus Christ,” he says in the sting video.

Walker said COVID has been instrumental for Pfizer’s recent business success: “Part of what they [Pfizer scientists] want to do is, to some extent, to try to figure out, you know, how there are all these new strains and variants that just pop up. So, it’s like trying to catch them before they pop up and we can develop a vaccine prophylactically, like, for new variants. So, that’s why they like, do it controlled in a lab, where they say this is a new epitope, and so if it comes out later on in the public, we already have a vaccine working.”

At press time, the Project Veritas video-tweet had more than 19 million views, according to Twitter. PV only recently was welcomed back to the social media platform after it was purchased by self-described “free speech absolutist” Elon Musk.

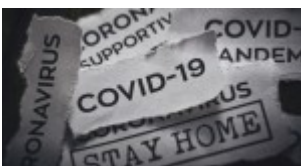

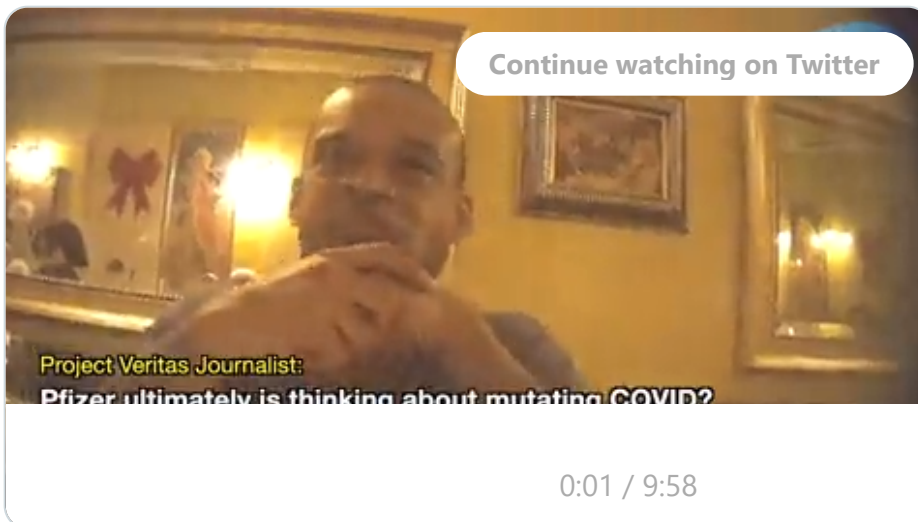
